In order that Indemnitee may rely on the indemnification promised by this Section, no repeal or amendment of this Section shall reduce the right of Indemnitee to payment of expenses or indemnification for acts of Indemnitee taken before the date of repeal or amendment. **ARTICLE XVIII – WORKERS' CREDENTIALS AND LICENSES** Credentials and licenses shall be granted by the Conference at its Constituency Meetings to all its approved workers, and during the interval between Constituency Meetings, by the Executive Committee. Eligible personnel for credentials and licenses shall be presented to the delegates during a Constituency Meeting after having been reviewed and recommended by the Conference Executive Committee. **ARTICLE XIX – EXTENDED REQUIREMENTS** The then existing requirements, discipline and General Conference working policies of the Seventh-day Adventist Church, so far as they shall apply, shall cover any matters not specifically covered by these Bylaws as though the same were set forth herein at length, and are by this reference made a part of these Bylaws and shall be binding upon all members, officers, and directors of this Conference. **ARTICLE XX – DISSOLUTION** In the event of dissolution of this Corporation, all assets remaining after all claims have been satisfied shall be transferred to the Pacific Union Conference Corporation of Seventh-day Adventists or its successors or designated alternate organization providing that at such time such organization shall qualify as an exempt organization under §501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any subsequent federal tax law. All such assets are to be utilized for the benefit of the individual churches comprising the Arizona Conference at the time of the dissolution.
